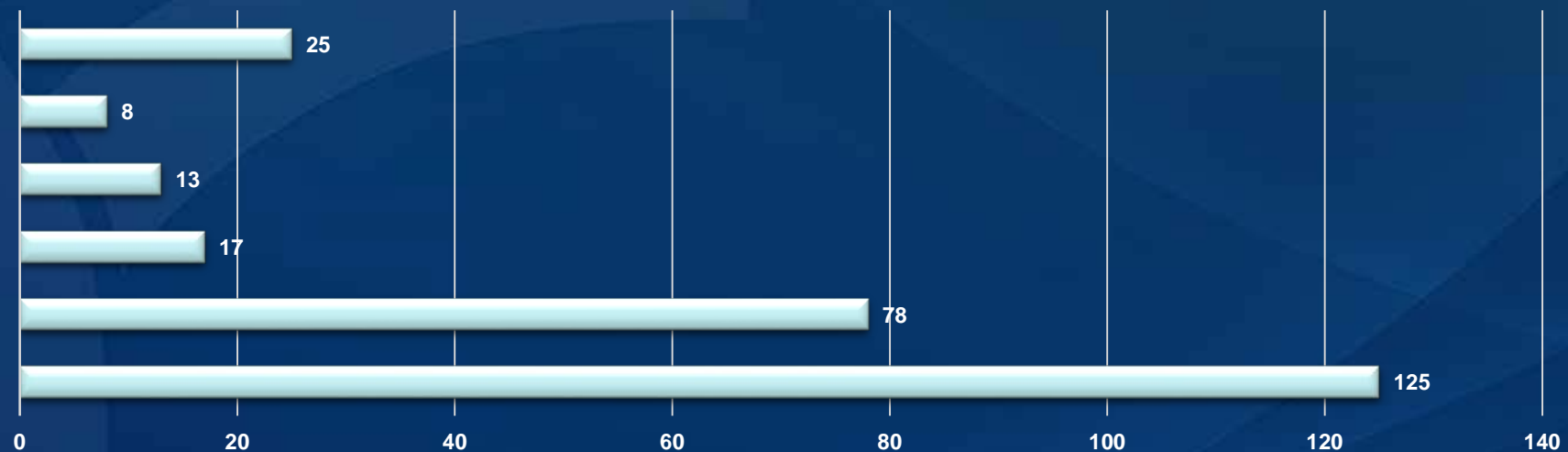

SYNOPSIS:

Staff will present one recommendation from the CARES Act Community Task Force:

- Award Food for Hope with \$13,900 to provide 200 weekly food bags to Thornton residents for the next 15 weeks

RECOMMENDATION:

The Task Force recommends Alternative No. 1, provide funding to Food for Hope in the amount of \$13,900.

Food for Hope: Overview of Need

Adams County reports, from March to April 2020, Thornton had an 18 percent increase in enrollment to the Supplemental Nutrition Assistance Program (SNAP), formerly called food stamps. Food for Hope is distributing 1,200–1,800 emergency food and supply bags per week to Adams 12, 27J, and Westminster Public Schools during the COVID-19 pandemic. In light of unemployment and economic instability, Food for Hope anticipates the need will remain high into the fall. Food for Hope has seen an increase of need for 200 additional bags per week at the Thornton High School location. These additional food bags would serve Thornton residents exclusively.

Food for Hope: Funding Calculation

Total Budget Amount: \$13,900

\$3.30 per bag x 200 bags per week= \$660 per week x 15 weeks= \$9,900
