Permit fees are based on the value or valuation of the project. The estimated cost to replace the building or structure in kind, based on current replacement costs, including labor, materials, overhead and profit. Value of remodel, renovation, or alteration projects will be calculated by doubling the estimated material costs.

\$100,001 - \$500,000		\$1000.25 for the first \$100,000 plus \$5.75 for each additional \$1,000 or fraction thereof, up to and including \$500,000		
\$500,001 - \$1,000,000		\$3240.25 for the first \$500,000 plus \$4.90 for each additional \$1,000 or fraction thereof, up to and including \$1,000,000		
\$1,000,001 and up		\$5615.25 for the first \$1,000,000 plus \$3.75 for each additional \$1,000 or fraction thereof
