Change of Location: No change of location of a licensed marijuana store shall be approved if the proposed location does not comply with the Development Code and zoning requirements set forth in Chapter 18, and the limitation on the number of marijuana store locations per geographical quadrant.

Modification of Premises: Per Rule 303, a licensee must submit an application prior to performing any material changes to the premises. Material changes include, but are not limited to: any increase or decrease in physical size, changes to ingress and egress from limited-access areas, the addition of sales counters or display cases, and the installation or replacement of electric fixtures or equipment for purposes of increasing production.
