Applicant Advisory

Due to the sensitive nature of some subjects being presented in the Thornton Police Citizens' Academy, a criminal history background check will be conducted on all individuals applying for attendance into the Academy. Individuals found to possess a criminal history will be individually evaluated as to the appropriateness of their attendance in the Academy.

Attendance by individuals possessing a felony conviction will be denied. The Thornton Police Department reserves the right to deny attendance based upon adverse criminal history information, or for any other reason.



Academy Application Procedures

To ensure a seat in the Citizen Police Academy, please complete the following application/registration process.

1. Application.

Please complete the application and return by hitting the “submit by email” button on the last page. You may also save the file and attach it if your email client does not open automatically. Or you may print and mail your application to the Thornton Police Department, 9551 Civic Center Drive, Thornton, Colorado 80229, Attention Officer Matt Barnes. Applicants must live or work within the city limits of Thornton to qualify. Please see the Citizen’s Academy brochure for more information.

2. Letter of Acceptance

Once your application has been processed and, if accepted, you will be sent a letter of acceptance/confirmation. This letter will provide you with the beginning date, time and location of the first class.

Instructions

It will be used as a basis for a criminal history check that will determine your eligibility for Thornton Police Citizen Academy. All information on this application will be kept confidential.

2. An accurate and complete form will expedite the criminal history check of your application.
3. This application should be printed or typed legibly if submitting by mail.
