



RESOLUTION

A RESOLUTION ADOPTING THE 2022 CITY COUNCIL MEETING SCHEDULE FOR THE CITY AND CHANGING THE DATES FOR CERTAIN REGULAR CITY COUNCIL MEETINGS.

WHEREAS, the City Council recognizes the importance of establishing a 2022 schedule for City Council Meetings, Updates, Planning Sessions, and other such meetings to enable Council to schedule time accordingly; and

WHEREAS, Section 4.10 of the City Charter provides that the City Council shall provide by ordinance for the time and number of regular Council meetings and may by resolution change the time and place of any regular meeting; and

WHEREAS, Subsection 2.52(a), by Ordinance 2644, establishes the second and fourth Tuesdays of each month at 7:00 p.m. as regular Council meetings; and

WHEREAS, the City Council recognizes the importance of scheduling additional times for Council to discuss important matters prior to, and in addition to, regular Council Meetings; and therefore, establishes Council Updates at 5:45 p.m. prior to the regular Council Meeting and Planning Sessions on the first and third Tuesdays of each month at 5:45 p.m.; and

WHEREAS, the regularly scheduled meeting of March 8, 2020 conflicts with the National League of Cities (NLC) Congressional City Conference; and

WHEREAS, the regularly scheduled meeting of June 28, 2020 conflicts with the Primary Election; and

WHEREAS, the regularly scheduled meetings of November 8 and November 22 conflict with the General Election and Thanksgiving holiday, respectively; and

WHEREAS, the regularly scheduled meeting of December 27 conflicts with the holidays; and

WHEREAS, the City Council realizes it may be necessary to schedule additional Planning Sessions, Special meetings, and Executive Sessions from time to time which cannot be appropriately scheduled in advance due to unforeseen circumstances.


